

## Request For Proposal

### Residential Treatment Facility-Adults

Magellan Behavioral Health of Pennsylvania, Inc. (Magellan), in collaboration with Bucks, Delaware and Montgomery Counties are soliciting proposals for a 14-16 bed RTF-A program for adult males and females with complex behavioral health needs. Interested providers must be able to launch the program with a complete staffing complement on 6/1/22. This program will be for the estimated duration of 18 months at a daily rate set at \$626 per member per day with consideration of an alternative payment arrangement during program ramp down. This rate has been set by BH-MCO and Primary Contractors and is non-negotiable. Interested providers must have a current PA RTF-A license (the need for a license expansion is allowable as long as it can be completed in the time frame) and identified space geographically relevant to Bucks, Delaware and Montgomery Counties or willingness to utilize space identified by the PA Department of Human Services (DHS). If the state location is selected, the rate will be contingent upon the site location up to \$626. Interested providers shall have experience in serving the serious and persistent mental illness (SPMI) population, providing treatment services to a justice-involved population and have experience with justice related services.

The program shall be designed for individuals who are State Hospital Forensic or Civil Commitments or Extended Acute Care/Acute Psychiatric Inpatient diversions or discharges, with the first admissions transferring from two RTF-A programs located on the grounds of Norristown State Hospital. Interested providers shall demonstrate a commitment to community re-entry and coordination of care with community based Behavioral Health Treatment Providers in the individuals' respective communities. Treatment planning must include the individual's natural supports, recovery and resiliency principles, and trauma-informed treatment.

All proposals must include the following:

- Site location to include address
- Budget and rate proposal
- A copy of the PA RTF-A license (license must be in good standing)
- Staffing roster to include credentials/specialties
- Program description to include evidence-based practices to serve the forensic population

Please be aware of the following associated details:
